## Parents' Evenings

#### **GCSE** and A level Exams

There has been speculation about the summer GCSE and A level exams and what it means for students. The current situation is that these exams are to be cancelled, but what will be in their place is as yet unclear as the government and Ofqual are in discussion about this. The message for students is that it is the learning that matters and they should focus on doing their very best with all of their work as it could all contribute to the final outcome in the summer, as was the case last year. As we know more, we shall, of course, keep you informed.

The latest information we can find suggests that the Vocational exams for Years 11, 12 and 13 **WILL** be going ahead next week. We will aim to provide confirmation of arrangements within the next 24-48 hours as regards these exams.
